



American Families Plan & Build Back Better Framework Discussion Guide

Recently, President Biden released the details of the American Families Plan and the Build Back Better Framework which has the potential to impact Head Start and other early childhood programs. While all the details have not been released, it is important to note the plan's call for a \$400 billion investment in early childhood, including free universal pre-school (UPK) for all three and four-year olds. The plan includes specifics such as raising the salaries of employees in pre-k and Head Start programs to at least \$15 per hour and staff with comparable qualifications will receive compensation to commensurate with that of kindergarten teachers.

The administration has also turned their attention to child care programs. The proposal for child care support includes investments to ensure low and middle-income families pay no more than 7% of their income towards high-quality child care. The plan also proposes funding for child care providers to improve quality focusing on small class sizes, coaching, culturally and linguistically responsive environments, and inclusive programming. Another aspect of the plan addresses the wages of child care providers using the same approach the administration is proposing for Head Start and UPK programs. All the changes and proposals may leave you wondering, "how will this impact my program". The questions below can be used to determine the best way to prepare your program to respond to changes in the early childhood landscape.

1. What is the make-up of your current state preschool system and what are its current impacts on your program? For example, is it administered in public schools and in other community-based programs?

preschool program in your area (call the schools or relevant	
agencies to get the most recent number of prek slots at each site,	
often data sources online are outdated)	
How many children aged three-years can be served in state	
preschool programs?	
What is the schedule of the prek program in your area (full-day,	
part-day, etc.) and when does it close during the year	
What are the enrollment trends in your program? Go back 10, 5,	
and 3 years to determine changes in the HS enrollment of three-	
and four-year-olds and review any EHS expansions.

- 2. How is Head Start different from state preschool? Are these differences likely to remain if the Build Back Better initiatives are implemented?
- 3. If there was an expansion of state preschool slots would your program be able to participate?
